Book Review: Voting Rights of Refugees by Ruvi Ziegler, reviewed by Ashwini Vasanthakumar The book argues that recognised refugees are a special category of non-citizen residents: they are unable to participate in elections of their state of origin, and are unable or unwilling, owing to a well-founded

fear of persecution, to return to it. Refugees deserve to have a place in the world, where their opinions are significant and their actions are effective. The Face of Violence: Rethinking the Concept of Xenophobia, Immigration Laws and the Rights of Non-Citizens in South Africa by Ngozi Odiaka

This article examines the constitutional rights of non-citizens in South Africa within the context of its immigration law and xenophobia. It argues that foreign nationals are particularly vulnerable to the restriction of their access to justice as the immigration laws and policies have not adequately guaranteed foreigners certain inalienable rights. The states uncoordinated attitude towards xenophobic attacks raises doubt as to whether there can be compliance with the sacred constitutional obligation to protect and preserve lives of all people within the country.
