Neo-liberalization, Devolution, and Refugee Well-Being: A Case Study in Winnipeg, Manitoba by Ray Silvius

Using a case study situated in Winnipeg, Manitoba, this article considers how refugee status and community actors contribute to refugee housing outcomes in a context in which refugee well-being is increasingly becoming 'neo-liberalized', or made a 'private' affair predicated on market processes and voluntary contributions. This paper reports on the research of the Landscape in Emergency Research Group and its explorations of the role of landscape design on the landscapes of displacement caused by the Syrian crisis in Lebanon. It explores the importance of the interaction and communication between design experts and community members in envisioning scenarios of intervention to address the adversity created by displacement and temporary settlement. Mapping the refugee reception in the Mediterranean, First report of the Evi-med project

By the end of 2015 an estimated 1,008,616 people had reached Europe by sea. This report examines what happened next and presents the results of a questionnaire on refugee and migrant reception administered to participants in Greece (300), Sicily (400), and Malta (50), followed by interviews with migrants (45) and key informants (50) including government representatives, humanitarian agencies, NGOs and activists. The findings illustrate distinctly different reception systems operating in Greece, Italy and Malta. It also highlights the impact of factors such as gender and age. Available at:

Access to Durable Solutions Among IDPs in Iraq, a report by IOM and Georgetown university.

This longitudinal study identifies the ways in which displaced Iraqis experience displacement, adapt to their circumstances, and create durable solutions. Through surveys of about 4,000 Iraqi families displaced since January 2014, and qualitative interviews with host communities and IDPs, the study aims to help researchers and policymakers build more accurate and nuanced understandings of IDPs' realities in order to foster more effective durable solutions. Understanding public attitudes towards refugees and migrants by Helen Dempster and Karen Hargrave

This working paper is intended as a primer – outlining current global polling data on public attitudes, and analysing what the literature has to say about the drivers influencing attitudes towards refugees and migrants within their host communities these attitudes. Some of the conclusions highlight the importance of understanding the real world concerns, as well as the emotions and values around which attitudes are formed and how it is important to root the latter in national and local contexts. Another interesting conclusion draws attention to the fact that traditional approaches to public engagement, such as 'myth-busting', may have exacerbated negativity and are unlikely to resonate beyond those who are already supportive. Reframing Non-Refoulement as an Individual Right under International Law? By Jenny Poon

This blog highlights the debate surrounding the principle of non-refoulement regarding when the principle applies (i.e. when the individual has entered State territory or at the frontier of the territory) and whether it applies extraterritorially (i.e. when the individual is under the effective control and authority of the State but not within its territory). The article argues that the above debate misses a critical analysis of whether non-refoulement is merely a right of the State or whether it is also an individual right under international law.
